## **Lear Brace, Ph.D. Receives Glenn Foundation for Medical Research Postdoctoral Fellowship in Aging Research**

Novato, CA — Lear Brace, Ph.D., a postdoctoral fellow at the Buck Institute for Research on Aging, has been awarded a one-year, \$60,000 Glenn Foundation for Medical Research Postdoctoral Fellowship in Aging Research, administered by the American Federation for Aging Research (AFAR). This program was developed to support postdoctoral fellows who study basic research mechanisms of aging and/or translational findings that have direct benefits to human health.

With the support of the award, Dr. Brace will investigate the relationship between sex, age, and the development of metabolic diseases. This study will investigate the role of FGF21 in protection from diabetes progression, the contributions of sex chromosomes or gonadal hormone secretions to the different response to over-nutrition and age, and if anti-inflammatory therapies could help modulate the mTORC1-related metabolic dysfunction and improve health and life-span.

“Our aim is to support research that leads to a greater understanding of biological aging that will contribute to the development of treatments or preventive measures that extend human healthspan,” notes Mark R. Collins, President of the Glenn Foundation for Medical Research.

Since 2014, the Glenn Foundation for Medical Research Postdoctoral Fellowships in Aging Research program (formerly known as the Glenn/AFAR Postdoctoral Fellowship Program for Translational Research on Aging) has provided more than \$2,200,000 to 40 postdoctoral fellows nationwide. Awardees are selected by a committee of distinguished scientists working in the field of aging research.

“We are pleased to collaborate with the Glenn Foundation for Medical Research to translate the knowledge in the basic biology of aging into therapies and interventions that will help us all live healthier and longer as we grow older,” notes Stephanie Lederman, Ed.M., Executive Director, AFAR.
